A. Description of original monument and accessories and/or subsequent restoration:

Sec Cor common to Secs 15, 16, 21 & 22, T25N-R12W; "Wood stake witnessed by Sugar 20" N49W 12 links and a Sugar 12" 539 E 51 links", U.S. Survey by Alvin & Austin Burt dated November 1838. "Fd stone with thrashing machine cylinder iron beside witnessed to the Twp Hall N54 1/2 E 1.3 chains", a 1903 survey by Co. Surveyor Allyn recorded in the Co. Surveyor Records of G.T. County. "NW Sec Cor stone", Govt Monument Witnesses Record card on file with the G.T. County Road Comm. and dated June 1970. "Fd 1 1/4" solid iron rod in the C/L of black top road intersection North, East & South", a LCR by Carl F. Roser dated April 8, 1980 and recorded in L.2, Pg.424 of the LCR's of G.T. County.

3. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Sec Cor common to Secs 15, 16, 21 & 22, T25N-R12W; Fd an 1 1/4" solid iron bar in a monument box directly over a large granite stone that was 36" deep, as recorded in L.2, Pg.424 of LCR's G.T. County and is accepted as a careful and faithful perpetuation of the position of the original corner. Remonumented this position with a 2 1/2" x 30" flanged bottom galvanized iron pipe with a 3 1/4" brass Cap stamped GRAND TRAVERSE COUNTY REMONUMENTATION, 4" below the surface of the road and replace the monument box.
