- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- J10 C 1/4 Corner Sec. 26 Set 2" Alum. Cap on 5/8" x 60" long iron rebar in center of rotten old wood anchor post bottom at intersection of old down fence remains N, S, E, & W. This position believed to be historical position set by Slawson in 1876. Slawson's witnesses are gone. This position is N26°16"W 3.53' from intersection of 1/4 lines. 2" Alum, Cap at fence corner accepted as the best available evidence of the position of the corner. Also found a 3/4" iron pipe noted by Wilcox that is S12°18'W 20.34' from 'J10'. The origin of this pipe is unknown and doesn't conform to any occupation or proper section subdivision.
  - Reference Pt. N44°20'48"W 109.27' from 'J10' -- found 1/2" capped iron #14102 per Wilcox. A blunder was made in the establishment of this iron. Doesn't fit Wilcox's Survey dimensions or any intersection of 1/4 lines.
