The monument was recovered and additional witnesses were made by Dennis Destrampe RLS #18983, date unknown: 11" Maple S55°W 45.49', 8" Maple S15°W 15.80', 5" Maple S78°E 18.36', 5" Maple S78°W 40.31'.

b.) Southwest 1/16 corner, Section 6. Not previously monumented.

## Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

- a.) Found the 1963 monument disturbed, having been knocked over by equipment or fallen tree. the 1963 position at record bearing and distance from the stump remains of one of the 1963 NBTs and from two of the Destrampe witnesses, Sugar S78°E and Sugar S15°W, both in good condition and found with UPEA #18983 tags set with spikes in the sides of the trees. Reset the 1963 monument at this position.
- b.) Established the position for the corner at the intersection of straight lines connecting opposite 1/16 corners, all monumented.
