A. Description of original monument and accessories and/or subsequent restoration:

(G10) Quarter corner common to Sections 27 and 28. 1953 - Dean C. DeLaMater RLS reestablished the position for the corner by proportionate measurement while making a partial resurvey of this township. No original evidence was found. Set 1"ID I.pipe with 4" brass cap. 12" Ash N22E 42 links, 10" H.Maple S56W 52 links.

(G11) Corner common to Sections 27-28-33-34. 1953 - Dean C. DeLaMater RLS reestablished the corner position by double proportionate measurement. One possible original B.T. in place, in poor condition. 1997 - The 1953 monument was recovered and recorded by the undersigned (erroneously noted as having been reestablished by Billy D. Buckler RLS). 1997 NBTs: 8" Hemlock S25E 17.9', 7" Y.Birch S43W 2.7', 5" Sugar N42W 9.6', 8" Hemlock N56E 6.9'. Rec. in LC 3, Page 420.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(G10) Found the 1953 monument in good condition and at record bearing and distance from the Ash NBT, now 18" DBH with overgrown blazes. The monument is N31°W 13.5' from the midpoint of the mile. However, the 1953 field notes do not explain if the proportionate measurement used to reestablish the corner position was based on adjacent Section corners only, or if it was based, in part, on measurements to feature calls. I accepted the monument as a careful and faithful reestablishment of the position of the original corner.

(G11) Found the 1953 monument in good condition and at record bearing and distance from the 1997 witness trees. Set measuring nails in the side of the 1997 trees and made new measurements to them, as described below. The 1953 NBTs were also found at record bearing and distance, now both stumps but scribing visible on the Hemlock.
