Set 1" pipe with 4" brass cap. 10" H.Maple S70E 14 links, 14" H.Maple S40W 48 links. 1995 - The 1953 monument was recovered by MDNR forester Otto Jacob. Mr. Jacob blazed and scribed 4 adjacent trees facing the monument.

(2-Sec. 29) East 1/16 corner between Sections 20 and 29. Not previously monumented.
