A. Description of original monument and accessories and/or subsequent restoration:

(II3) Standard Section corner to Sections 34 and 35, T53N-R35W. Not a common corner with Sections 2 and 3, T52N-R35W. 1845 - W.A.Burt, Deputy, set post. Birch 14" N09°E 16 links, Fir 8" N14°W 28 links. 1944 - William A. Waara "found 4" sq. ced.stke. in level ced. swamp. Found 22" bir. B.T. with P.A.L. mark N14°E 12 ft. Found 14" sq. off spruce N46°W 5 ft. Found 20" r. map. B.T. S50°W 20 ft. Put Y. tag on 4" r. map. S62°W 6 ft. Put names and W.A.W. mark on 6" hem. S28°E 6 ft." 1846 - S.W. Higgins, Deputy, running between Sections 2 and 3, T52N-R35W, intersected the Township line 30 links west of the Standard corner and set post. Maple 9" S48°E 16 links, Spruce 12" S48°W 32 links.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(II3) Did not find the cedar stake noted in 1944. Remonumented the corner at record bearing and distance from the Y.Birch B.T. 14" N09°E 16 links, now a rotted stump with no marks visible, approx. 24" dia., and at record bearing and distance from the two W.A.W. NBTs - Maple S62°W 6 ft. (no tag found), and Hemlock S28°E 6 ft. Both of the 1944 witnesses are in good condition with overgrown blazes. Also found the 14" sq. off spruce N46°W 5 feet noted in 1944, now a rotted stump mound at record bearing and distance. I note that the Closing Corner B.T. Maple S48°E 16 links is in place, living, with rotted face. Found traces of the measuring notch facing NW, toward the position of the C.C., which was not remonumented this date.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(II3) Set 1"IDx28" I.pipe with 2" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: 5" Hemlock N37°W 10.35' mrkd "S34 NBT" 12" Maple N59°E 8.1' "S35 NBT" 14" Hemlock S24°E 6.25' mrkd "S2 NBT" (1944 NBT) 10" Maple S54°W 6.6' do do Set sq'd cedar post adjacent.
