Part A: Corner History

$\underline{G5}$ – corner common to sections 9, 10, 15 & 16 T25N R6W $\underline{G6}$ – ½ corner common to sections 15 & 16, T25N, R6W

- 1852 GLO Cannon set post corner of sections 9, 10, 15 & 16. -
 - 1) Tamarack 14" S57°W 8. 2) Tamarack 12 N57°E 17.
- 1940 Marcus Schaaf field notes, book T25N, R6W, page 46 - Both BT stumps in place, but post rotting, exact. Also an old squared cedar stake rotted off and on ground. Corner in swamp about 2.75 ch from East edge of swamp. -
 - 3) W. Pine stump 24" S82½°E .92 4) W. Pine stump 28" S28°E 1.53

 - 5) W. Pine stump 26" S75°W 1.49
- 1954 DNR Corner Record Dean C. DeLamater, PS# 5778 - This corner was located by Forestry Division survey crew, while making a partial resurvey of the township. Corner was previously established by Marcus Schaaf, Registered Land Surveyor in 1940. Original BT's in place but very poor condition. - 1" pipe with 4" brass cap. -
 - 5) 12" Cedar S70°W 231/2 links
 - 6) 5" Cedar N40°W 45 links

- 1852 GLO set quarter section post -
 - 1) Tamarack 8" N22°E 50.
 - 2) Balsam 6" S73°W 9.

Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

G5 - corner common to sections 9, 10, 15 & 16 T25N R6W G6 - 1/2 corner common to sections 15 & 16, T25N, R6W

Found 4" department of conservation brass cap on 1" pipe. Found accessories #2(stump remains), #5(dead stub) & #6 fitting position of monument. Accepted the position of found 4" department of conservation brass cap on 1" pipe as a careful and faithful perpetuation of the position of the original corner.

Searched area near single proportion position. Found possible Schaaf pit to the Northwest. Schaaf set monuments at G5 and G7, but have no record of him setting a monument at G6. Dug a 4' X 6' search area from the possible Schaaf pit in search of monument or wood stake. Nothing found. Set a stamped 4" DNR aluminum cap on 1" X 36" long galvanized iron pipe at single proportion position. N58°W 31.8' to possible Schaaf pit. Accepted 4" DNR aluminum cap on 1" X 36" long galvanized iron pipe as a careful and faithful reestablishment of the position of the original corner.

S87°E 19.14' to set nail & tag in NE. side 6" Black Spruce S53°W 42.82' to set nail & tag in NW. side 12" Cedar N36°W 30.02' to set nail & tag in NE. side 12" Cedar N07°W 37.02' to set nail & tag in W. side 11" Cedar

a stamped 4" DNR aluminum cap on 1" X 36" long galvanized iron pipe. – Set blue post 1' North.

N25°E 56.39' to set nail & tag in SE. side 7" J. Pine S37°E 5.41' to set nail & tag in SW. side 6" W. Pine S23°W 61.05' to set nail & tag in NW. side 7" J. Pine N52°W 27.70' to set nail & tag in NE. side 3" W. Pine
