B. Description of corner evidence found and/or method applies in restoring or re-establishing corner:

F-1 - Standard 1/4 corner common to Section 4, T25N, R6W & Section 33, T26N, R6W- Found 1" Fargo Pipe w/ Conc. Mon. along side- 0.24' SE per LCRC's & Rec. survey. Dug down and found the crockery in place around Fargo's 1"X2.3" long pipe with hooked end. CL of N-S gravel rd. is 16.5± W. Accepted Fargo's Pipe as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

F-1- Removed 1" Fargo Pipe & conc. Mon. and replaced with 4" DNR

Alum. Cap on 1" X 36" Galv. Iron pipe at Fargo pipe position.

Reset 7 FND. piece's of broken crockery at base of Mon. as memorial.

Set blue carsonite post 1'N
