Found 4" Department of Conservation aluminum cap on 1" pipe in good condition. Found accessories #3, #4, #5 & 6. No GLO evidence was found. The found 4" Department of Conservation aluminum cap on 1" pipe is accepted as a careful and faithful reestablishment of the position of the original corner.
