Found ½" rebar at road surface. Directly below ½" rebar found a 4" Brass monument. Found accessories #3, #5, #6, #7 & #8. No GLO evidence was found. Left monument in place. The found 4" Brass monument is accepted as a careful and faithful reestablishment of the position of the original corner.
