- 1850 GLO Lucius Lyon set sugar post for 1/4 corner 1) Hemlock 12" S79°E 18L. 2) Hemlock 14" N23°W 23L.
- 1967 DNR corner record and survey map plan No. R-40-AU. K. J. Ostling, PS #10068 This corner was set by proportionate measurement between section corners. Falls between old fence lines running West and East, and acceptably in line with segments of old fence row from South. Checks good to marsh crossing North. Could find no previous corner. Set 1" pipe with 4" aluminum cap. 3) 8" H. Maple N34°E 18.2', 4) 6" H. Maple N45°W 21.8'.

Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

#### C2 - 1/2 corner common to sections 5 & 6, T27N, R8W

Found 4" aluminum Department of Conservation cap on 1" pipe in good condition. Found accessories #3 & #4. No GLO evidence was found. The found 4" aluminum Department of Conservation cap on 1" pipe is accepted as a careful and faithful reestablishment of the position of the original corner.

#### C2 - 1/4 corner common to sections 5 & 6, T27N, R8W

4" aluminum Department of Conservation cap on 1" pipe. Blue post 1.5' South.
