#### C3 - corner common to sections 5, 6, 7 & 8, T27N, R8W

- 1850 GLO Lucius Lyon set Beech post for corner of sec. 5, 6, 7 & 8. - 1) Beech 8" N47°W 30L. 2) Beech 9" S23°E 58L.
- 1967 DNR corner record and survey map plan No. R-40-AU. K. J. Ostling, PS #10068 This corner was restored during a survey of this area. Set corner at proportionate measurement North- South, and in line with old established fence and occupation line South. Found large stone at corner which may have been set to mark the corner in previous survey. Checks acceptably for E-W proportion. – set 1" pipe with 4" aluminum cap below surface. – 3) 10" H. Maple N32°W 27.6', 4) 9" H. Maple S64°W 27.4'.
- **1967** Consumers Power Co. Map –Drawing No. S-F 16878 1" iron W/ cap **3**) 12" Maple N32°W 28,2', **4**) 10" H. Maple S64°W 28.0', 5) 10" Maple N25°E 26.5'.
- 1998 LCRC L. 3, P. 82, C. W. McVean, PS #39088 Found 4" DNR A.C. on 1" Iron Pipe per KJO and CPC surveys, buried 0.1'. Fences, down, West are 15'+ North and 32'+ South. Fence, down and in trees, South is in line and fence, down and in trees, North is 12'+ East. Monument accepted as a careful and faithful reestablishment of the position of the original corner. Built ring of stones around found monument and set blue carsonite post with location tag 16.5' South. - 4) 15" Sugar Maple S62°W 27.97; 3) 16" Sugar Maple N32°W 28.17'; 5) 16" Sugar Maple N26°E 26.25'; 6) 10" Red Pine S30°E 68.01'; 7) 10" Red Pine S40°W 77.30'.

# Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

### **C3** - corner common to sections 5, 6, 7 & 8, T27N R8W

Found 1" pipe at road surface with ring of stones per 1997 LCRC. Found accessories #3, #4, #5, #6(stump), and #7 fitting position of pipe. Cut off 6" of pipe to lower below road grade and added 4" stamped DNR aluminum cap. Monument accepted as a careful and faithful reestablishment of the position of the original corner.

## Part C: Field Evidence of Perpetuation or Monumentation of Corner(s)

#### **C3** - corner common to sections 5, 6, 7 & 8, T27N, R8W

a stamped 4" DNR aluminum cap on 1" pipe. - Found blue post with location tag 16.5' South.
