Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

D3 - 1/2 corner common to sections 5 & 8, T27N, R8W

Found a broken 4" department of conservation aluminum cap on 1" pipe per 1967 corner record, 12' South of East-West 2-track centerline. No GLO evidence was found. Replaced the broken cap with a stamped 2" aluminum cap. The 2" aluminum cap on 1" pipe is accepted as a careful and faithful reestablishment of the position of the original corner.

A stamped 2" aluminum cap on 1" pipe. - Set blue post 1' North.
