## Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

# F3 - 1/4 corner common to sections 4 & 9, T27N, R8W

Found department of conservation cap on 1" pipe per 1967 DNR corner record. Found accessories #3, #6 (dead stub), 7, and #8 (blown down) fitting position of monument. No GLO evidence was found.

Accepted the department of conservation cap on 1" pipe as a careful and faithful reestablishment of the position of the original corner.

#### F3 - 1/2 corner common to sections 4 & 9, T27N, R8W

A department of conservation 4" aluminum cap on 1" pipe. - Set blue post 1' North.
