A. Description of original monument and accessories and/or subsequent restoration:

G-4C 1831 G.L.O. Notes Mullett Corner Falls in "Lake" (River) - Set Temporary Point
1992 L.C.R.C. #6566 T. Chettleburgh Set K.C. Monument w/Witness Cap

This corner was originally approved by the Kent County Remonumentation Peer Group and monumented by T. Chettleburgh on 5/27/92 and was recorded per L.C.R.C. #6566.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

G-4C Found a Standard Kent County Monument 20' East of the East bank of the Thornapple River, 118.56' East of G-4, T5N, R10W, as set by T. Chettleburgh on the E-W 1/4 line of Section 10 per L.C.R.C. #6566.
