Description of corner evidence found and/or method applied in restoring or reestablishing corner:

D-11 Found standard Kent County Monument 1.0' South of C/L of 100th Street running E-W and 1.0' East of C/L of Homerich running N-S per L.C.R.C.'s #1633 and #4658 as set by Nederveld & Jonker in place of 3/4" iron over 2 plow points which checked L.C.R.C. #212.
