This corner was originally approved by the Kent County Remonumentation Peer Group and monumented by Nederveld Associates on 9/4/81 and was recorded per L.C.R.C. #2307.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

F-13 Found standard Kent County Monument at the C/L intersection of 108th Street running E-W and Westan Avenue running N-S. This point is on the Town line and is common with the N 1/4 corner of Section 4, T4N, R12W, per L.C.R.C.'s #4427 and #4652 as set by Nederveld Associates in place of a 1/2" iron they found which checked K.C. Surveyor Wit. Map.
