on 2/20/81 and was recorded per L.C.R.C. #1820.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

J-1 Found standard Kent County Monument on the C/L of 60th Street running E-W and on a tree row running South per
L.C.R.C.'s #910, #1820 and #4738 as set by Exxel Engineering in place of a 1/2" Iron they found which checked L.C.R.C.'s
#910 and #1053. This point is on the Town line and is 25.82' West of the SW Cor., Sec. 36, T6N R12W.
