B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

H-8 Found capped iron 4-5' West of fence corner running N-S, E & W per L.C.R.C. #1390 as set by Exxel Engineering at the intersection of 1/4 line. This point could be 4.5' M/L West of the Center Section as shown in 1904 Williams & Works notes and Williams & Works surveys 1904-1957 which noted the fence corner. Capped iron is 0.2' North and 0.1' East of the intersection of 1/4 lines. Accepted iron as the Center Section.
