1826: U.S. Government Survey; Set 1/4 Section Post.

Hickory 12" South 25° West 10 Lks  
Beech 14" North 58° East 6 Lks

1870: F. Hodgman, County Surveyor; Quarter Section Corner. Found original stake hole in road. Planted stake and brick.

Maple 8" South 80° West 41½ Lks  
Maple 10" North 15° East 86½ Lks

1921: Kalamazoo County Road Commission; East 1/4 Post Section 8, Stone.

Hickory 8" N 75° E 27.2' Maple S 80° W 27.4' Fence East and West on Line 27'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: North of iron rod at Sta. 79+20.6

1944: Wilkins and Wheaton Engineering Company; Found iron.

1971: D. Ratekin, Surveyor; LCRC, Liber 1, Page 7, Found 1/2" iron 0.4' below pavement.

1978: Al McMachen, Surveyor; LCRC, Liber 1, Page 721, Found iron.

1994: Found iron (1/2" x 20") in Centerline of Road. Dug a hole (7' x 4'). Found no other evidence. Ran the East Line of Section 8. Measurement to the Northeast Corner (ratified July 21, 1994) was 2643.37'. Measurement to the Southeast Corner (Not ratified, LCRC, Liber 1, Page 185) was 2646.36' and the angle from the Northeast Corner to the Southeast Corner (angle right) was 180°-00'-27".

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E-4 East 1/4 Post Section 8, T. 1 S., R. 11 W., Ratified by the Kalamazoo County Remonumentation Program Peer Group on July 21, 1994. Found iron as shown on 1944 survey by Wilkins and Wheaton Engineering Company, 1971 LCRC and 1978 LCRC and is accepted as a careful and faithful perpetuation of the position of the original corner. Placed a 20" Harrison monument in place of iron with a monument box over.
