- 1826 Corner established by U.S. Deputy Surveyor, Robert Clark, Jr. Beech 13 in. S 78 ° W 12 lks. Beech 5 in. N 26½ ° E 10 lks.
- 1872 Samuel Hodgeman: "Stone with drill hole + side stones N + S 50 lks."

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Original monument and accessories not recovered. No surface monument found. Excavated a 7'  $(N+S) \times 17'$   $(E+W) \times 7'$  deep hole centered on the bisection of a line between corners E7 and G7. Found no evidence of stone w/drill hole. Area may have been excavated for road. Side stone to the north gone due to fiber optic installation. Side stone to the south gone due to driveway cut.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

F7, South Quarter Post of Section 16, Town 4 South, Range 9 West. Ratified by the Kalamazoo County Remonumentation Peer Group on December 17, 1998. The position of the bisection of the line between corners E7 and G7 is accepted as a careful and faithful reestablishment of the position of the original corner. Set a 30" Harrison Monument in a mon. box at said bisection.
