

- F9 1838 GLO S. Sibley Cedar 8" Cor. Tree - 1975 - LCRC - L. C 2, P. 246 - C. F. Roser (PS #12028)

- 1) 7" Cedar N45°W 35.0'
- 2) 10" Cedar N75°E 25.2"
- 3) 8" Cedar S22°E 21.0'

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- F9 ~ 1/4 Corner common to Sections 21 & 28, T19N, R12W Found 4" Dept. of Conservation (DOC) Aluminum Cap on 1" iron pipe per Roser in cedar and ash swamp. No GLO evidence found. Condition of witnesses as follows: #1 & 3 are dead; #2 – dying. Measured West 122' to east bank of Baldwin River and West 133' (199' – GLO) to West bank of Baldwin River – Course South. DOC Monument accepted as a careful and faithful reestablishment of the position of the original corner.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- F9 4" DOC Aluminum Cap on 1" galv. iron pipe Up 1'. Set Blue Composite post 1' SW N43°E 35.89' to set nail and tag (N & T) in SE side 12" Cedar scribed 'XBT' S27°W 53.04' to set N & T in W. side 9" Cedar scribed 'XBT' N74°E 25.55' to set N & T in S. side 14" Cedar – dying (#2) S6°E 54.69' to set N & T in W. side 7" Basswood N76°W 15.15' to set N & T in S, side 9" R. Maple
