

B. Description of comer evidence found and/or method applied in restoring or reestablishing corner: 1/4 Corner common to section 7 Township 45 North, Range 12 West and section 12 Township 45 North, Range 13 West.

This corner is being re-established as part of the Luce County Remonumentation Program.

The 1986 DNR resurvey of the range line inadvertently used a witness pipe at Section Corner 18, 19, 24 and 13 to prorate against. This caused five corners re-established in that survey to be South and East of their true prorated position.

Found 1 1/2" pipe with a 4" aluminum Michigan Department of Natural Resources cap 15.90 feet South and 16.86 feet East of prorated position. Contacted MDNR and reset Michigan Department of Natural Resources monument by single proportionate measurement using section corner 18, 19, 24 and 13, 1 1/2 miles to the South and the Township Corner 1 1/2 miles to the North. Distance South is 7940.04 feet (GLO - 7920 feet). Distance to the North is 7878.50 feet (GLO - 7858.62 feet).

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: 1/4 Corner common to section 7 Township 45 North, Range 12 West and section 12 Township 45 North, Range 13

Corner is a 1 1/2" pipe with 4" aluminum Michigan Department of Natural Resources cap, driven over a 1/2" x 48" rerod. MICH ŌF
