A. Description of original monument and accessories and/or subsequent restoration:



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(D7) Found the 1980 monument in good condition and at record bearing and distance from two of the three 1980 witnesses: The J.Pine S41°E is in good condition; the Oak N64°W is actually a Maple, in good condition with scribing visible; the W.Birch S60°W is now a stump. Left the monument in place and made new witnesses as described below.
