

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set brass cap in 36" pipe at surface grade. 41.12' N 80° E nail & tag South side 8" Oak 35.43' S 80° E nail & tag South side 6" Oak 39.05' South nail & tag East side 26" Oak 7.83' N 30° W nail & tag Northeast side 26" Hickory

SUMMARY M-7

NORTHEAST CORNER, SECTION 24, T1N-R5E HAMBURG TOWNSHIP, LIVINGSTON COUNTY, MICHIGAN.

Found 1" inch rerod (no cap) 2 feet ± West of new fence and in tree row North and South. Government Land Office notes and map, call for 8.75 chains (577.5 feet) South to Northwest corner Section 19, T1N-R6E, Green Oak Township. Boss Engineering measures 563.21 feet and H.C.M.A. Measures 563.59 feet to same Section 19 corner. (A found concrete monument). Also found monument at Northeast corner of "Riverbendwillo Subdivision No.2" platted on 7-14-54 by McMahon Engineering. Measured recorded distance of 483.06 Southerly along East line of Section 13 and found Boss iron at S.E. corner Lot 66 of said plat. Continued South to Section corner and measured recorded distance of 251.56 feet to found 1" inch rerod.

Conclusion: We find the ½" inch rerod as found in North-South tree row, to be at the same location found by McMahon Engineering in 1954. And accept as Northeast corner Section 24
