do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefor as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below.

A. Description of original monument and accessories and/or subsequent restoration:

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This location was determined from an analysis of deeds in the area and their relationship with the nearby plat of "PEACH'S SUBDIVISION NO. 2". Deeds show that there was a 50 foot wide parcel adjacent to the south line of the subdivision. A retracement survey of the subdivision and the adjoining property was conducted. The Corner was placed on the straight line between Corners G-7 and G-9 at the intersection of a line from the center of Section and a line 50 feet south of the South line of "PEACH'S SUBDIVISION NO. 2". This point is in Silver Lake. Reference Point No. 1 was placed on the East-West 1/4 line of Section 21, S 86°50'12" W, 54.39' from G-8 on the shore of Silver Lake. Reference Point 2 was placed on the line between Section 21 and 22 on the shore of Silver Lake S 03°31'44" E, 283.18' from corner G-8. A line between Reference point 1 and Reference point 2 has the bearing of S 14°23'35" E, and distance of (005-006) 288.70'
