A. Description of original monument and accessories and/or subsequent restoration:

Original $\frac{1}{4}$ Corner placed by William Ives, D.S. Oct. 26, 1849.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Found a $1\frac{1}{2}$ " iron at corner, placed by unknown Surveyor. Land owners report this corner in place prior to 1958.

Corner lies 144' South of an old Grade.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a 1" pipe with 4" aluminum cap at corner.
