Description of corner evidence found and/or method applied in restoring or reestablishing corner: SE Cor Sec 36 (24-14) & SW Cor Sec (23-14) & NE Cor Sec 1 (23-14) & NW Cor Sec 6 (23-13) On June 22, 2000, I Anthony M. Slawinski, along with a field crew from Abonmarche, found a PK nail raised over a boat spike which was raised over a 1/2" by 12" iron rod (set by Ostling in 1960) which was raised over a 1" pipe monument. The concrete had been broken away from the top 1/3 of the monument. We found no other evidence to dispute the location of this corner.

Condition of witnesses: #1 gone, #2 gone, #3 gone, #4 gone, #5 gone, #6 good, but tree is dead and starting to decay.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: SE Cor Sec 36 (24-14) & SW Cor Sec (23-14) & NE Cor Sec 1 (23-14) & NW Cor Sec 6 (23-13) On June 22, 2000, I installed a Manistee County Monument, within a monument box, in the exact location of the above mentioned concrete monument as a careful and faithful re-establishment of the position of the original corner, and witnessed by:
