_ , in a field survey on _ 11/30/1994 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

NOTE: Not more than 4 corners, all in the same town and range, may be recorded on this certificate.

Description of original monument and accessories and/or subsequent restoration:

C-2, T8S, R7E, Bedford Township, Monroe County - ID No. 58 1/4 corner Common to Sections 5 and 6 (School and Secor Roads - 4 inchs asphalt over 12 inches stone over sand)

1820, G.L.O. Surveyor, Joseph Wampler, between Sections 5 and 6 set quarter section post witnessed: B. Oak 30 (inch) South 48 links & B. Oak 12 (inch) North 34° 67 links. 1942, Road Commission witness card shows found stone. 1946, O.A. Case surveyed "Golden Meadows". 1948, O.A. Case survey and A.J. Marino survey of Bauman Plat would appear that Bauman Plat used point 4 foot +/- East of Case survey. 1955, M.R. Fleck survey of Golden Acres. 1961, A.J. Marino field notes state F.I. and F. Valve 0.67 feet south and 3.67 feet West. 1984, G.B Warnke field note show found I.P. and railroad spike 1.70 feet west. 1990, G.B. Warnke survey states found 1/2 inch iron pipe (5 inches deep) over found pipe straight 8 inches deep, raised with railroad spike.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

C-2 - 8/29/1994, found railroad spike over bent 1/2 inch iron pipe +/- on high point of stone at 18 inches deep, at 28 inches found remains of wood stake or post, lots of black soil at base, 0.2 feet north and 0.15 feet east of "+" cut in railroad spike. Set 1 inch X 36 inch iron pipe in monument box, placed pieces of stone, railroad spike and iron pipe surrounding base of pipe and witnessed as shown below. NOTE: The auto valve which was 3.5 feet +/- west and appears to have fit as 1/4 corner for "Golden Meadows" was not found, road was repayed 5-10 years ago. Also, plat monuments for Golden Acres and Bauman Plat appear to have been destroyed by road ditch cleaning. 11/30/94, set brass remonumentation cap on 1 inch x 36 inch iron pipe inside monument box.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

C-2 - Set 1 inch X 36 inch iron pipe with brass remonumentation cap in monument box to replace old markers and is accepted as the best available evidence of the position of the original corner and Witnesses:
