Description of original monument and accessories and/or subsequent restoration:

D-8, T8S, R7E, Bedford Township, Monroe County - ID No. 58

Center Corner for Section 20 (Consear Road - tarby road)

G.L.O. did not set centers of sections. Witness card notes found stone 9-11-42. 1956, Melvin R. Fleck surveyed "Barbara Lee Manor", Liber 10, Page 41, tied to center; momumentation used not noted. 1972, M.R. Fleck survey, recorded in Liber 636, Page 139, to R. spike. G.B. Warnke: in 1974, (73-108) notes set 1 inch i. bar over stone 3 feet deep; in 1975, recorded LCRC, Liber 2, Page 136, to 1 inch iron bar over 3/4 inch i. pipe 2 foot deep over stone 3.5 foot deep; and has used to present. M.R. Fleck: 1975 survey, recorded in Liber 729, Page 624, notes FD. R.R.SPIKE. 1993, James Van Havermaat survey & letter notes iron bar, had been mistaken for R.R. spike, and R.R. spike was not found.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

D-8 - 11/1994, found 1 inch iron bar over iron pipe over stone and witnessed as shown below. 12/14/94, set 1 inch x 36 inch iron pipe with brass remonumentation cap inside monument box to replace bar over pipe over stone.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

D-8 - Set 1 inch x 36 inch iron pipe with brass remonumentation cap inside momument box to replace 1 inch iron bar over 3/4 inch iron pipe being 2 feet deep over stone being 3.5 feet deep. This position not established by original government surveyors. This monument is accepted as the best available evidence of the position of the corner. Witnesses: OF MICA
