A. Description of original monument and accessories and/or subsequent restoration:

M-2: East 1/4 Corner of Section 1.

PK nail in utility pole N70W 36.99'

1844: William A. Burt's original survey notes describe the corner monument as a post referenced by:

Hydrant valve nut N20W 64.88'

9" Cedar N73E 13 l

SW corner building N25E 80.49'

8" Fir N80W 6 l

NW corner building N85E 27.81'

1983: A Land Corner Recordation Certificate filed by Charles F. Clark RLS No. 25836 indicates a 1 1/2" iron pin under manhole cover witnessed by:

1986: Certificate of Survey recorded Liber 357 pg. 568 filed by Larry Bussonne RLS No. 25833 indicates the East 1/4 Corner of Section 1, T47N-R27W as recorded in Liber 4, RC pg. 247. No corner accessories given.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1994: Found and accepted the 1 1/2" iron pin as referenced in part "A" above. A 3/4" bolt was welded to the top of the pin and a Marquette County Survey Monument was placed on top of the bolt. Distance South is 2618.45' (2618.79' Maas) and distance North is 2633.12' (2632.38' Maas). Corner is in centerline of Tobin St. South of Jackson St. in the City of Negaunee.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

1994 - Set a 3 1/4" diameter aluminum tablet Marquette County Survey Monument stamped to identify the corner referenced by nail in:

Power Pole N74W 36.91 ft. Clark Accessory

Hydrant (Northerly most valve nut) N25W 64.72 ft. Clark Accessory

Southwest corner Senior Citizen Bldg. N27E 80.43 ft. Clark Accessory

Northwest corner brick bldg. foundation N77E 27.80 ft. Clark Accessory

Monument is under a manhole cover and is set in concrete 0.95' below road surface. Bearing tree tags were set on the power pole accessory but no sign post was placed.
