## A. Description of original monument and accessories and/or subsequent restoration:

(E5) Corner common to Sections 8-9-16-17. 1992 - Corner monument recovered and recorded by Paul N. Bressette, PS 37270. Found 1" iron pipe and dead J.Pine witness N30E 48.2' set by MCRC in 1947. Replaced with MDNR monument. 12" J.Pine N10E 29.8', 8" Maple S10E 2.7', 4" Maple S89W 50.9', 6" Maple N14W 35.9'. Found no subsequent record.

(2-Sec. 16) East 1/16 corner between Sections 9 and 16. 1992 - Established by Paul N. Bressette PS 37270 midway and on line between Section and Quarter corners. Set MDNR monument. 10" Maple S64E 12.8', 10" Maple S70W 33.1', 10" Hemlock N88W 34.5', 10" Maple N03W 27.1'. Found no subsequent record.

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (E5) Found the 1992 monument in good condition and at record bearing and distance from two remaining 1992 NBTs. The Maple SE and the Maple NW are in good condition. The J.Pine NE and the Maple SW were not recovered. Accepted the monument as the best available evidence of the position of the original corner.
- (2) Found the 1992 monument in good condition and at record bearing and distance from two remaining 1992 NBTs. The 10" Maple SW and the 10" Hemlock NW are in good condition. The other NBTs were not recovered. I did not make any measurements to this corner and this certificate is being filed to update the accessories of the monument as found.
