K10 – ¼ Corner common to Sec. 25 & 26 – Fd. 5/8" CIR #12028 per C. F. Roser. Centerline of N-S sand road is 3' E. Centerline of sand road to West that runs to 'J10' is 61'± South. Witnesses #1, 2, 3, 4, & 5 are gone. Witnesses 6 & 7 are OK. No evidence of stake per Co. Survey record. No evidence of Schaaf Block monument. A line from corners 'I-10' through 'J10' projected East would intersect the section line 53.4' South of 'K10'. It appears that the road to the West was probably built on the extension of the E-W ½ line from 'J10' but there is no good reason to believe this road intersection 61' South of 5/8" CIR is proper location for 'K10'. Thus accepted 5/8" CIR as a careful and faithful reestablishment of the position of the original corner.
