

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- K6 1/4 Corner common to Section 13 & 14, T21N, R6W Fd. 4" DNR Alum. Cap on 1" iron pipe in grassy marsh per Roser. No evidence of GLO BT's or post were found. Condition of Roser's witnesses as follows; #3 - Fd. ½ dead - 127.1' to Blaze; #4 - Fd. Dead Stub - 135.8' to face. GLO topographic calls from random line are North 2 chains to Edge of marsh and south 4 chains to edge of marsh. DNR Monument accepted as a careful and faithful reestablishment of the position of the original corner.
