Distance E. to I11 fits 1915 Subdivision of Sec. 34 apparently by E.A. Beuthein. CL. Rd. to south is 36' +/- West. 1915 survey also shows this CL. to West but no definite dist. Monument accepted as the Best available evidence of the position of the original corner.
