# Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

H7 - 1/4 Corner common to Sec. 15 & 22, T23N, R7W - No GLO evidence was found. Set stamped 4" DNR Aluminum Cap on 1" x 4' long galvanized iron pipe by single proportion between 'l-7' and reestablished 'G7'. Corner in Cedar swamp. Grid distance East and West is 2642.51' vs. 2640' - GLO. DNR Monument accepted as a careful and faithful reestablishment of the position of the original corner.

PCC near H7 – Fd. ½" capped iron #14102 is N89°02'W 24.64' from 'H7'. Could not accept this iron as 'H7' since it is based on rejected position at 'G7'. This property controlling corner is recorded by this surveyor strictly to comply with the requirements of P.A. 74 of 1970 as amended and P.A. 345 of 1990 as amended and is not an endorsement of the corner position.
