Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

M10-A10 - Standard 1/4 Corner common to Section 25, T24N, R7W and Sec. 30, T24N, R6W - Fd. 1" I.D. iron pipe in concrete base per J. G. Cavanagh 1909 retracement and remonumentation survey in Pioneer Twp. Monument was found under the S'ly root of a large Maple clump. Condition of witnesses as follows: #1 through 5 are gone. #6 through 11 are not applicable to this monument. Centerline of N-S 2-track is 8' East but corner is basically on line with centerline of the 2-track N & S, the road just curves around the Maple tree at this point. 1" pipe in concrete accepted as the best available evidence of the position of the original corner.

Reference Pt. 'A' - Fd. 1/2" iron rod per LCRC #56 is S68°49'W 35.99' from 'M10-A10'. 1/2" iron rod not utilized as 'M10-A10' in this survey.
