C6 - 1853 - GLO - T. Whelpley - Set 1/4 Post

- 1) Maple 4" N69°E 34 L.
- 2) W. Oak 10" S50½°W 23 L.



B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

C6 - ¼ Corner common to Sections 17 & 18, T24N, R8W - No GLO evidence was found. Set DNR Monument by single proportion between 'C5' and 'C7'. Grid distance N and S is 2654.07' (2640' - GLO). DNR Monument accepted as a careful and faithful reestablishment of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

C6 - 4" DNR Alum. Cap on 1" x 36" long galv. iron pipe.

- Set Cedar post 1' North
- S66°E 35.60' to set N & T in SW side 11" Oak
- S21°W 64.83' to set N & T in W. side 6" Oak
- N45°W 8.21' to set N & T in SW side 6" R. Maple
- N5°W 100.90' to set N & T in W. side 10" W. Pine
