B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
1998-Kennedy Surveying, Inc. - Kennedy, PS #17623 - Fnd a 4" diameter Concrete Monument with a 2" diameter brass cap stamped Oakland County Remonumentation #24598 located 34 feet West of the existing centerline of Inkster Road extending to the North & South, which has a bituminous surface, and in the existing centerline of Quarton Road extending to the East, which has a bituminous surface. This corner is being used and accepted as a common corner with Sections 19 & 30, T2N, R10E, Bloomfield Township (A-9).
