B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Recovered 3/8" rerod on side of hill. There are no occupation lines  
running from the corner. Corner confirmed with monumentation found  
in the "Thendara Park Country Club" subdivision recorded in L 38,  
P 40, O.C. Records, and survey west of subdivision by Kieft Engineering.



C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set concrete monument with remonumentation brass cap, replacing 3/8" rerod.

N 35°E 17.65' PK/remon tag SW face 14" hickory

N 10°E 7.92' PK/remon tag SE face 16" ash

S 89°E 14.34' PK/remon tag S face 12" ash

S 10°E 8.31' PK/remon tag SW face 18" oak
