I, Randy Kolehhouse, in a field survey on 19 95, do hereby certify that under requirements of P.A. 74 Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

## A. Description of original monument and accessories and/or subsequent restoration:

## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E-1 This corner falls in Brooks Lake survey drawing per S. Cooley 1872 shows this corner to be 2869.68' West of N 1/4 corner Section 4 (F-1). Survey prepared by Baldwin shows same measurement to N 1/4 Section 4 (F-1) and also shows E-1 to be 536.06' West of the E-13 Lapeer County.

Found an old 3/4" iron at both the N 1/4 corner of Section 4 and E-13 Lapeer County.

Measure between corners = 2322.64'

Baldwin Survey Measures = 2333.62'

Decided to hold Baldwin distance of 536.06' West of E-13 Lapeer County to establish E-1. Used line of iron West of E-13, to establish section line. Total distance measurement from this point to G-1 is 5724.84'. Record distance per Cooley 1872 and Baldwin 1930 is 5739.36' or 14.52' longer than our measured distance. Found a 3/4" iron on East bank of Brooks Lake 48.55' East of computed location of E-1. This point is on town line as established.

Because the best evidence on record for this corner is the Baldwin measurement to E-13 Lapeer County, I recommend that this corner be established holding said measurement as defined above and reference monument be set.

## C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E-1 Replaced the 1/2" rebar with a 4" x 36" concrete monument with brass cap stamped "Oakland County Remonumentation P.S. #25854."

PK Nail & Tag Stamped "Oakland Co. Remonumentation P.S. #25854" in W Face 5" Cedar N 52° E 67.00'  
 PK Nail & Tag Stamped "Oakland Co. Remonumentation P.S. #25854" in NW Face 24" Red Pine N 70° E 22.13'  
 PK Nail & Tag Stamped "Oakland Co. Remonumentation P.S. #25854" in N Face 12" Oak S 84° E 37.84'  
 PK Nail & Tag Stamped "Oakland Co. Remonumentation P.S. #25854" in W Face 12" Cedar S 17° E 21.87'  
 E. Edge Lake West 6.00'
