B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

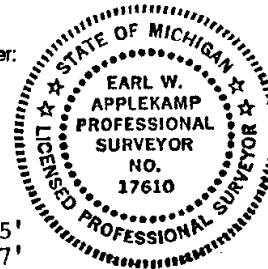
No original evidence was found. Calculated Corner position falls in an old graded up road running North & South with some gravel, but now is grass covered. From the calculated position an old fence runs East and West with fields being farmed NE & SW from this position. I re-established the corner at the intersection (os) the center-line of the old road and the fence lines East & West as being the only logical position for the corner.

Research on file with the Ontonagon County Remonumentation Program Representative.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position I set a 2½"x30" split base aluminum pipe with a 3" cap flush with the top of the old road. Cap is stamped to read: County Remonumentation, T49N, T48N, R41W, S1, S2, S35, S36, 2000, P.S. 17610. I established 3 bearing trees and a reference object.
