

A. Description of original monument and accessories and/or subsequent restoration:

(H - 1) North 1/2 Corner Section 3, T51N, R39W. * Note: This corner is not common with 1/2 corner in Section to South.

This corner was not set in the original survey but was protracted midway between NW & NE corners of Section 3 (closing corners) for acreage calculations.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found no evidence of any kind at this corner position. I established a position for this corner midway between closing corners and on line between the SE corner and S 1/2 corner of Section 34, T52N, R39W. The corner now falls on the Northerly edge of a power line clearing and at the southerly edge of a clear-cut.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
