

I found no record of subsequent restoration.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found a 1" x 5" iron pipe at the corner position. Distances from this pipe to the rotted remains of both original bearing trees check well. The 10" Hemlock is rotted to ground level and partially submerged in a beaver dam. The 24" Hemlock is also rolled to ground level. Distances to section corners North and South work well with GLO. I have accepted the iron pipe as the true 1/2 corner and replaced it with a county monument.
