B. Description of corner evidence found and/or method applied in restoring of reestablishing corner:

I found the 3" Clay Tile by Trumbull in a low swampy area. Corner is in line with old fence line to the South and in an extension of an old fence line from the east.

Condition of the accessories are as follows: #1 Gone, #2 Gone, #3 Gone, #4 Gone.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I set a 1" x 30" Pipe with Osceola County Remon Iron in the center of the Tile, and is accepted as a careful and faithful perpetuation of the position of the original corner.
