A. Description of original monument and accessories and/or subsequent restoration:

Original corner established by William A. Burt, U.S. Deputy Surveyor, August 12, 1847. Set Cedar Post.

ORIGINAL BEARING TREES:

8" Aspen S15°E 3.96 feet  
6" White Birch N77°W 9.90 feet

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No original evidence was found. Apparent corner location is on a gravel road running North & South. This road has been in existence since the 1920's. At the apparent corner position a well maintained fence runs East along a woods & field line. Field is being actively farmed. Corner was re-established at intersection of the fence line and centerline of the gravel road. Corner position is in conformance with the original survey calls.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position I set a 5/8"x12" rebar with a 3" stamped cap 5" below top of gravel road surface. I established a reference monument, a 2 1/2"x30" aluminum pipe with a 3" cap stamped to read: County Remonumentation, T48N R41W, R42W, R.M., S18, S19, S13, S24, 1997, P.S. 17610. I also established 3 other reference objects.
