A. Description of original monument and accessories and/or subsequent restoration:

Corner established by William Burt on 6/19/1848. Original B.T.s --- Sugar 18" N.45 W. 18 links (11.88') --- Sugar 14" S.35 E. 33 links (21.78) ---

Corner re-established by Richard L. Drahn (21564) on 5/7/81 by single proportionate methods. He set a 2" X 30" aluminum pipe with a 3 1/4" stamped aluminum cap and the following references:

7" Sugar Maple N.80 W. 16.25'  
7" Sugar Maple N.30 E. 10.62'  
6" Sugar Maple S.02 W. 14.44'

Corner recorded in Ontonagon County in Liber 2, Page 66 on 6/15/82.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Research form on file with Ontonagon County records.

Recovered Mr. Drahn's monument as described and his B.T.s as follows:
