Not previously monumented.

(14-Sec. 14) Established the position for the corner midway and on a straight line between Quarter
corner 1310.85' north and Section corner 1310.85' south.

(16-Sec. 14) Established the position for the corner midway and on the Section line between Section
corner 1325.95' east and Quarter corner 1325.95' west.
