

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No original evidence found. At the corner position I found a 1½" pipe, pipe is identified in MDOT road plans for US-45. Pipe is also identified in the assessor's plat of Donnelly's subdivision No. 2, in the SW½ of Section 31, T52N R39W. Corner was used for Jones Subdivision of NW½ of Section 6, T51N R39W. Owner of the property at this corner, Jerry Koski, a Survey Technician, testified this corner has been there for many years and used for several surveys in the area. I accepted this position and monumented the corner as described below in "C".

Research on file.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position I set a $2\frac{1}{2}$ "x30" aluminum pipe with a $3\frac{1}{4}$ " cap stamped to read: COUNTY REMONUMENTATION, T51 & 52N, R39 & 40W, S.1, S.6, S.31, S.36, 1995, P.S. 17610. I established the following bearing trees and reference objects:
