E-1 Found 1" iron pipe in mon. box on standard line 17.66' E of monument at E-13 - T13N - R4E. E-1 Monument fits centerline of Center Road S. Monument accepted as the best available evidence of the position of the original corner. Accepted by Saginaw County Peer Review Group on 9-30-93.

F-1 Found pk nail 17.16' E of 1" boat spike in mon. box per L.C.R.C. - L. 5, P. 180 - pk nail fell 0.08' S of standard line. Pk nail fits occupation S. This position not established by original government surveyors. Monument is accepted as the best available evidence of the position of the corner. Accepted by the Saginaw County Peer Review Group on 9-30-93.
